

Terms of use of the AV-POLAND.com website

\$ 1. Definitions

1.1 Rules and Regulations - these Regulations.

1.2 Rules and Regulations of the Event - rules and regulations specifying detailed conditions of organisation and participation in a particular event organised by the Motor Transport Institute

1.3. AV-POLAND/Portal - website made available via the Internet, serving among others to register for Events, whose owner is Motor Transport Institute, based in in Warsaw, postal code 03-301, at 80 Jagiellońska Str., entered in the register of entrepreneurs kept by the District Court for the city of Warsaw, 13th Commercial Division of the National Court Register under the number KRS 0000130051, NIP 5250008382, REGON 000127692.

1.4 Personal data administrator - Motor Transport Institute, based in in Warsaw postal code 03-301 at 80 Jagiellońska Str., entered in the register of entrepreneurs kept by the District Court for the city of Warsaw, 13th Commercial Division of the National Court Register (KRS) under KRS number XIII.

1.5 Participant - a person who has successfully registered for an Event via website.

1.6 Organiser - an entity that is the actual organiser of an Event.

1.7 Event - an event of a scientific and business nature, the participation in which the Organiser provides to registered users.

1.8 Fee - the fee for participation in an Event determined by the Organiser, which is paid by the User after registering for the Event.

\$ 2 Types and scope of services

2.1 The Portal AV-POLAND.com provides Users with data and information about Events made available by the Organizers on the Portal.

2.2 Users can register for Events through the Portal.

\$ 3 Registration for an Event

3.1 By registering for an Event, the User declares familiarity with and acceptance of Terms and Conditions of the Event, which are made available to him/her electronically before registration.

3.2 When registering for an Event, the User is obliged to provide all the data required by the Organiser.

3.3 In order to successfully register for an Event, it is necessary to carry out a full registration using the registration form and the Fee, if required in the Event Regulations.

3.4 Fee amounts are inclusive of VAT and all other taxes.
